

## **Outdoor Signage Laws in the News...Again**

On February 29, 2016, The Outdoor Circle sent an Action Alert to its members asking all to voice their opposition to Bill 78 which would allow commercial signs on all city assets including facilities, vehicles, equipment, programs and parks. The word "sign" in the bill was changed to "sponsorship recognition" and "sponsorship message" but a commercial sign by any other name is still a commercial sign.

If Bill 78 is passed, we could have "commercial sponsorship recognition and messages" on signs at Kailua Beach Park, the Kailua District Park Rec Center and at our iconic Boettcher Estate at Kalama Beach Park. Our Lanikai-Kailua community would have NO voice in regulating the type, size or placement of these commercial messages since these decisions are outside the jurisdiction of the Kailua Neighborhood Board. Over ninety city parks around the island would be impacted in addition to Blaisdell Center, rail cars and stations, Foster Botanical Garden, Ho'omaluhia and Lili'uokalani Botanical Gardens to name a few.

In response to the Action Alert, the City Council Budget Committee was inundated with emails and phone calls opposing the bill. Members showed up to testify against it. Special thanks go to LKOC Board Members Diane Harding and Kathleen Bryan for addressing complex legal and financial issues raised by the Budget Committee, to Leigh Prentiss for her expertise in sign laws, and to Paula Ress who related from personal example that individuals (and thus presumably corporations) can adopt a park without the need for public recognition in the form of signs. The Budget Committee voted to "defer" the bill making it inactive unless reintroduced in the next two years.

**Did you know?** Currently, four states—Hawaii, Alaska, Vermont, and Maine—have prohibited billboards. Hawaii's territorial law went into effect in 1927 and the statewide ban followed in 1961; Alaska's law went into effect upon its achievement of statehood in 1959; Vermont's law went into effect in 1968; Maine's law went into effect in 1977.

## **New LKOC Bylaws**

The LKOC Board has revised our Bylaws (last updated in 2010) to better reflect the current structure of the branch organization and our current branch practices. We are presenting these new **Restated and Amended Bylaws - 2016** to the general membership for ratification, at the May 13 Annual Meeting.

You can view a full copy of the **Restated and Amended Bylaws** on our website at LKOC.org (or view a hard copy at the Kailua Public Library). In these views, all the changes are highlighted for easy reference.

The significant changes include:

#### 1) Elected Board

- Reduce the number of <u>required</u> Vice Presidents to 1 rather than 4.
- Include only the Nominating Committee Chair as an elected officer, not the full Nominating Committee.

#### 2) Standing Committees

• Restate the definition of Standing Committees to better reflect the current operating structure.

#### 3) Meetings and Quorum

- Reduce the number of <u>required</u> general membership meetings to 1 per year, not 2.
- Reduce the quorum needed for LKOC Board meetings to 40% (not 50%).

#### 4) General

- Where necessary, restate language to comply with current TOC Bylaws and policy.
- Where necessary, remove references to activities or practices no longer conducted.

#### Kalama Beach Park Invasive Species Cleanup

LKOC and volunteers from the Pali Lanes Lions Club were out in force at Kalama Beach Park to remove invasive species that had overrun parts of the landscaping there. In particular, the naupaka, which LKOC had replanted 10 years ago, was being



strangled by ivy gourd and other vines, as well as being invaded by Christmas berry and other unwanted shrubbery. Thanks to these dedicated volunteers, the naupaka on the makai side of the property has now been revitalized and should start to thrive again! Thanks to Paula Ress for coordinating the event with City and County officials, and to Jay Floan from Pali Lanes Lions for generously offering the services of their crew of volunteer members.



### FLASHBACK from the Honolulu Star Bulletin, May 2, 1950 "Women of Outdoor Circle Go Into Action on Sky Advertising"

The women who knocked the billboards right out of Honolulu and off of Oahu are now going after night sky advertising. The Outdoor Circle has warned persons interested in flying illuminated signs at night that they will combat this new form of open air advertising which, says the Outdoor Circle, is disfiguring. Last Friday night, Island Aviation, Ltd., put on a flight for a brand of whiskey. The plane carried neon billboards into the skies of Oahu. Immediately the Outdoor Circle and others got protests. Protests came both from residents and from visitors. They declared that the beauty of Hawaii's tropic skies at night is being marred by these "sky-riding billboards." The Outdoor Circle has now given "friendly warning" to both the plane owner and the whiskey importer that, unless the sky advertising is canceled, the ladies will fight the scheme with every resource in their power.

[Note: Three weeks later, the whiskey company agreed to give up their "sky-sign" campaign even though they were breaking no law at the time. The Honolulu Star Bulletin reported that "they understood the logic of the principle of successful business—'You can win an argument and lose a sale.'" The city banned aerial advertising in 1978.]

## WCCC/LKOC Back on Track

Thanks to generous grants from the Harold K. L. Castle Foundation and Hawaiian Electric Company, the Learning to Grow Program at the Women's Community Correctional Center is up and running after severe storm damage last spring. And the Community Work Line is fully functional again after the loss of equipment due to a theft last spring.

For the Learning to Grow Program our volunteers and facility students were able to repair the existing hydroponics lines and construct a fifth line. The whole system is now fully functional producing lettuce for the



facility cafeteria. The students are receiving certified instruction in Hydroponics and Horticultural skills and will soon start a class in How to Start a Small Business. These classes have been extremely well received by the participants who have found them very enriching. Thirteen students have graduated from the first Hydroponics class! Our volunteers are developing plans to sell additional lettuce in the local community to help make the program self-sufficient.

The Community Work Line women have new weed whackers to more effectively continue their landscape maintenance of public areas around Kailua and Kawainui Marsh. Since 1999, LKOC has provided all of the work equipment and other support features for the Work Line.

Volunteers are needed to help with these vital programs at WCCC. Two volunteers are needed to help assist the women learn horticulture skills and grow hydroponic vegetables for commercial sales. Another person is needed to help with marketing the produce. If you are interested in helping with these programs, call Terry Beuret at 389-0188.
